

## Conservation Report: Reeds Creek

At this writing, Reeds Creek is frozen over and is quite deep above the beaver dam, which is located on the west side of the Hwy. 21 bridge.

Until Lake Norman began rising in December, the area below the dam was mostly dry and silt-filled, which created an ideal time to collect litter and golf balls which drift down the creek from the Mooresville Public Golf Course. The area was cleaned of litter, but unknown quantities of trash are most likely trapped behind the dam under water and ice.

The salt block for the deer has been recently replaced and is being used. Activity regarding the Coverboard Project has been suspended until spring.

Now that 2011 has arrived, preparations for the transfer of ownership and maintenance responsibilities of the Reeds Creek Wetland acreage should be accelerating, since the work contract between the state and Mid-Atlantic Earthmark Mitigation LLC is coming to an end.

We will be in close contact with Mid-Atlantic as the time grows closer in order to make early contact with whichever state agency is taking responsibility for the project.



### Reeds Creek Wetland in Winter

*Located off Hwy. 21 between the Huntington Woods and Cypress Landing neighborhoods of Mooresville, the 15-acre wetland provides a home for native wildlife, from tree frogs and dragonflies to wood ducks and great blue heron. A great fish habitat, it is a perfect hunting ground for osprey and bald eagles. It also is a rest-stop for migrating birds. LNWC volunteers placed bird and bat nesting boxes in the wetland and enjoy monitoring wildlife populations year-round.*

LNWC volunteer **Don Higgie** reported that hunters are shooting geese and ducks from a blind across the Cypress Landing gazebo adjacent to the creek. Posting of the Reeds Creek Wetland area to further protect wildlife will be a topic of discussion with the state once it takes ownership. We will also research providing a wildlife viewing area for the public.


Short talks will be given on such topics as use of native plants, sustainable landscaping, organic gardening, attracting birds and butterflies; and composting methods. For the kids, we will have a pinecone birdfeeder station, face-painting and a live animal show.

### Wildlife Habitat Components

1. **Food**—Berry or seed-bearing trees & shrubs; feeders; native flowering plants.
2. **Water**—Anything from a simple bird bath to a water garden. You can even create a low-lying area for butterflies and amphibians.
3. **Cover**—Also known as shelter, this includes mature trees, a hedge, ground cover or a rock garden. Bird houses are great for sheltering birds in the winter.
4. **Places to Raise Young**—Bird houses, mature trees, dead trees, native shrubs.
5. **Sustainable Gardening**—Avoid artificial chemicals.

## Free Nature Programs

## Friendly Developments, etc

Have you heard about the NC Wildlife Federation's newest program? The **Wildlife Friendly Development Certification Program**, in cooperation with the NC Wildlife Resources Commission and the American Society of Landscape Architects, is designed to recognize residential developments that promote conservation of wildlife habitats by providing food, water, cover and places to raise young, as well as sustained maintenance of contiguous natural areas.

Other initiatives receiving attention from NCWF in 2010 include:

- ◆ The battle to regain control of the Yadkin River flow being championed by the Stanly County Commissioners and other local leaders.
- ◆ Duke Energy's request to the Federal Energy Regulatory Commission to obtain a new license to operate its 13 hydroelectric stations and 11 reservoirs on the Catawba River.
- ◆ Working with Land For Tomorrow to conserve NC's parks, game lands, and working farms for the future.
- ◆ Working successfully in several key mountain locations to protect stream buffers for quality resources and trout fishing.
- ◆ Helped secure 88 acres to be transferred to the U.S. Forest Service, allowing access to the lower Catawba 100-foot falls and the 70-foot upper falls in the Pisgah National Forest.
